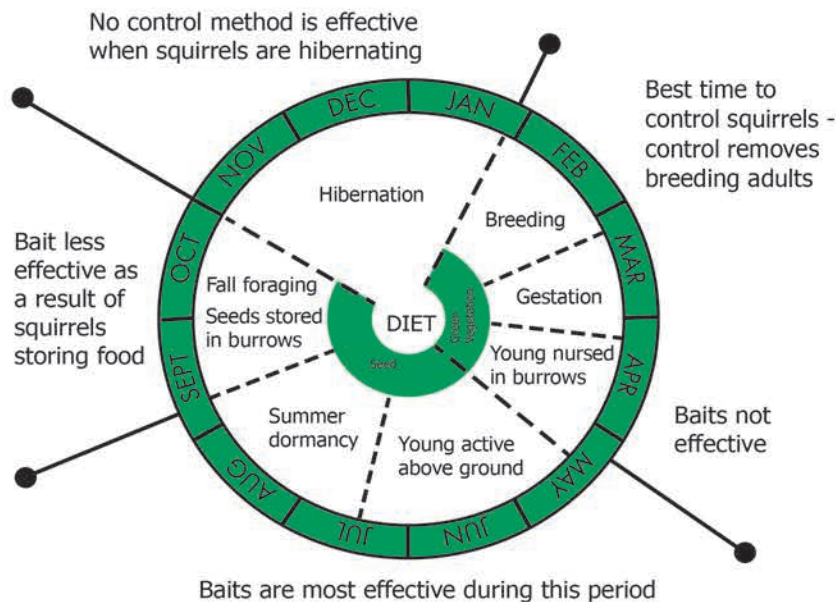

- Ground Squirrel behavior may vary based on climate, geography, and seasonal changes
- Baits are most effective when squirrels are actively feeding and competing food sources are less available
- Always follow label instructions

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **READ THIS LABEL:** Read this entire label and follow all use directions and use precautions. Use only for the sites, pests, and application methods described on this label.

IMPORTANT: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents:

- Store unused product out of reach of children and pets.
- Apply bait in secured, tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. Units must be secured or otherwise immobilized.
- Dispose of product container and unused, spoiled, or unconsumed bait as specified on this label.

Do not sell this product in individual containers holding less than 4 pounds of bait.

CALIFORNIA GROUND SQUIRRELS

USE RESTRICTIONS: This product may be used for the control of the California ground squirrel (*Spermophilus beecheyi*). Product may only be applied within 100 feet of man-made structures. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, agricultural and public buildings, and related structures around and associated with these sites. Bait must be placed in secured, tamper-resistant bait stations.

APPLICATION DIRECTIONS:

Place and secure tamper-resistant bait stations near active burrows or in other locations where activity of California ground squirrels is evident. Space these bait stations at intervals of 20 to 75 feet in areas infested by California ground squirrels. Apply 2-4 pounds of bait per bait station. Check bait stations every 2-3 days, or more frequently, for signs of bait consumption and possible problems in the treated area. Replenish bait stations as necessary to maintain a continuous supply of bait but not to exceed 4 pounds of bait in any one station. Continue baiting until there no longer are signs of feeding on bait by California ground squirrels.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed. Keep away from children, domestic animals and pets. All handlers (including applicators) must wear: shoes plus socks, and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear waterproof gloves.

Anticoagulant Diphacinone: For animals ingesting bait and/or showing poisoning signs (bleeding or elevated prothrombin times), give Vitamin K₁.
